**SUBJECT:** Revenue and Expenditure Reports

Attached is the Controller's Summary of Budget to Actual report, Selected Budgetary Fund Balance report and the Budget to Actual report for the period ending January 31, 2017.

For the period ending January 2017, Percent Collected on the Statements of Actual & Budgeted Revenue and the Percent of Budget Expended on the Statement of Actual & Budgeted Expenditures should both be at 8% if collected and expended evenly throughout the year.

Budgetary Fund Balance is the cumulative residual balance after subtracting expenses from revenues, based on a cash basis. Budgetary Fund Balance at January 31, 2017 was \$12.8 million in the General Fund, \$512,325 in the Neighborhood Services Fund, \$1,463 in Sanitation and \$4,225 in Disposal. Finance agreed to the accuracy of the amounts for the December 2016 Budgetary Fund Balance on February 6, 2017. The Remaining Budgetary Fund Balance amounts in the report were calculated by subtracting the 2017 Appropriated Budgetary Fund Balance and January 2017 Expenditures from the December 31, 2016 Budgetary Fund Balance, then adding the January 2017 Revenues.

Through the end of January:

1. City Council has expended or encumbered 25% of its services budget.
2. Solicitor's Office has expended or encumbered 55% of its services budget.
3. The Bureau of Financial Management has expended or encumbered 60% of its services budget.
4. Information Technology has expended or encumbered 40% of its services budget, 68% of its supplies budget and 96% of its other budget.
5. Parks and Recreation has expended or encumbered 32% of its services budget and 34% of its supplies budget.
6. Police has expended or encumbered 33% of its services budget, 60% of its supplies budget and 27% of its other budget.
7. Fire Bureau has expended or encumbered 29% of its services budget and 38% of its supplies budget.
8. Public Works Director has expended or encumbered 33% of its services budget, 26% of its supplies budget and 18% of its other budget.
9. Vehicle Management has expended or encumbered 61% of its services budget and 64% supplies budget.
10. State Liquid Fuel Tax Fund has expended or encumbered 45% of its supplies budget and 33% of its other budget.
11. Host Municipality Fee Fund has expended or encumbered 70% of its other budget
12. Neighborhood Services Fund has expended or encumbered 32% of its supplies budget and 41% of its other budget.
13. Police Protection Fund has expended or encumbered 49% of its services budget.

**SUBJECT:** Revenue and Expenditure Reports

Attached are the Controller's Summary of Budget to Actual report, Selected Budgetary Fund Balance report and the Budget to Actual report for the period ending February 28, 2017.

For the period ending February 2017, Percent Collected on the Statements of Actual & Budgeted Revenue and the Percent of Budget Expended on the Statement of Actual & Budgeted Expenditures should both be at 17% if collected and expended evenly throughout the year.

Budgetary Fund Balance is the cumulative residual balance after subtracting expenses from revenues, based on a cash basis. Budgetary Fund Balance at February 28, 2017 was \$14.7 million in the General Fund, \$222,709 in the Neighborhood Services Fund, \$1,678 in Sanitation and \$5,149 in Disposal. Finance agreed to the accuracy of the amounts for the December 2016 Budgetary Fund Balance on February 6, 2017. The Remaining Budgetary Fund Balance amounts in the report were calculated by subtracting the 2017 Appropriated Budgetary Fund Balance and 2017 Year-to-Date Expenditures from the December 31, 2016 Budgetary Fund Balance, then adding the 2017 Year-to-Date Revenues.

Through the end of February:

1. City Council has expended or encumbered 28% of its services budget.
2. Solicitor's Office has expended or encumbered 32% of its services budget.
3. The Bureau of Financial Management has expended or encumbered 62% of its services budget.
4. Information Technology has expended or encumbered 39% of its services budget, 67% of its supplies budget and 85% of its other budget.
5. Planning has expended or encumbered 38% of its services budget.
6. Parks and Recreation has expended or encumbered 29% of its services budget and 51% of its supplies budget.
7. Police has expended or encumbered 33% of its services budget, 53% of its supplies budget and 31% of its other budget.
8. Fire Bureau has expended or encumbered 40% of its services budget.
9. Public Works Director has expended or encumbered 33% of its services budget, 46% of its supplies budget and 25% of its other budget.
10. Vehicle Management has expended or encumbered 46% of its services budget and 64% supplies budget.
11. State Liquid Fuel Tax Fund has expended or encumbered 44% of its supplies budget and 27% of its other budget.
12. Host Municipality Fee Fund has expended or encumbered 46% of its other budget.
13. Neighborhood Services Fund has expended or encumbered 41% of its supplies budget.
14. Police Protection Fund has expended or encumbered 46% of its services budget.
15. Events Fund has expended or encumbered 27% of its services budget.

**SUBJECT:** Revenue and Expenditure Reports

Attached are the Controller's Summary of Budget to Actual report, Selected Budgetary Fund Balance report and the Budget to Actual report for the period ending March 31, 2017.

For the period ending March 2017, Percent Collected on the Statements of Actual & Budgeted Revenue and the Percent of Budget Expended on the Statement of Actual & Budgeted Expenditures should both be at 25% if collected and expended evenly throughout the year.

Budgetary Fund Balance is the cumulative residual balance after subtracting expenses from revenues, based on a cash basis. Budgetary Fund Balance at March 31, 2017 was \$15.9 million in the General Fund, \$66,299 in the Neighborhood Services Fund, \$2,594 in Sanitation and \$7,147 in Disposal. Finance agreed to the accuracy of the amounts for the December 2016 Budgetary Fund Balance on February 6, 2017. The Remaining Budgetary Fund Balance amounts in the report were calculated by subtracting the 2017 Appropriated Budgetary Fund Balance and 2017 Year-to-Date Expenditures from the December 31, 2016 Budgetary Fund Balance, then adding the 2017 Year-to-Date Revenues.

Through the end of March:

1. Solicitor's Office has expended or encumbered 51% of its services budget.
2. The Bureau of Financial Management has expended or encumbered 64% of its services budget.
3. Information Technology has expended or encumbered 44% of its services budget, 68% of its supplies budget and 92% of its other budget.
4. Planning has expended or encumbered 43% of its services budget.
5. Parks and Recreation has expended or encumbered 64% of its services budget and 62% of its supplies budget.
6. Police has expended or encumbered 53% of its services budget and 50% of its supplies budget.
7. Fire Bureau has expended or encumbered 44% of its services budget and 39% of its supplies budget.
8. Public Works Director has expended or encumbered 42% of its services budget.
9. Vehicle Management has expended or encumbered 46% of its services budget and 63% supplies budget.
10. State Liquid Fuel Tax Fund has expended or encumbered 44% of its supplies budget.
11. Host Municipality Fee Fund has expended or encumbered 46% of its other budget.
12. Neighborhood Services Fund has expended or encumbered 41% of its supplies budget.
13. Police Protection Fund has expended or encumbered 46% of its services budget and 77% of its other budget.
14. Parks and Recreation Fund has expended or encumbered 72% of its other budget.

For the period ending April 2017, Percent Collected on the Statements of Actual & Budgeted Revenue and the Percent of Budget Expended on the Statement of Actual & Budgeted Expenditures should both be at 33% if collected and expended evenly throughout the year.

Budgetary Fund Balance is the cumulative residual balance after subtracting expenses from revenues, based on a cash basis. Budgetary Fund Balance at April 30, 2017 was \$12.6 million in the General Fund, \$286,081 in the Neighborhood Services Fund, \$3,012 in Sanitation and \$8,109 in Disposal. Finance agreed to the accuracy of the amounts for the December 2016 Budgetary Fund Balance on February 6, 2017. The Remaining Budgetary Fund Balance amounts in the report were calculated by subtracting the 2017 Appropriated Budgetary Fund Balance and 2017 Year-to-Date Expenditures from the December 31, 2016 Budgetary Fund Balance, then adding the 2017 Year-to-Date Revenues.

Through the end of April:

1. Solicitor's Office has expended or encumbered 53% of its services budget.
2. The Bureau of Financial Management has expended or encumbered 68% of its services budget.
3. Information Technology has expended or encumbered 53% of its services budget, 68% of its supplies budget and 93% of its other budget.
4. Planning has expended or encumbered 44% of its services budget.
5. Parks and Recreation has expended or encumbered 69% of its services budget, 64% of its supplies budget and 50% of its other budget.
6. Police has expended or encumbered 55% of its services budget and 54% of its supplies budget.
7. Fire Bureau has expended or encumbered 46% of its services budget and 44% of its supplies budget.
8. Public Works Director has expended or encumbered 44% of its services budget.
9. Vehicle Management has expended or encumbered 51% of its services budget and 63% supplies budget.
10. State Liquid Fuel Tax Fund has expended or encumbered 70% of its supplies budget and 50% of its other budget.
11. Host Municipality Fee Fund has expended or encumbered 46% of its other budget.
12. Neighborhood Services Fund has expended or encumbered 55% of its supplies budget.
13. Police Protection Fund has expended or encumbered 46% of its services budget and 77% of its other budget.
14. Parks and Recreation Fund has expended or encumbered 54% of its services budget and 72% of its other budget.

**SUBJECT:** Revenue and Expenditure Reports

Attached are the Controller's Summary of Budget to Actual report, Selected Budgetary Fund Balance report and the Budget to Actual report for the period ending May 31, 2017.

For the period ending May 2017, Percent Collected on the Statements of Actual & Budgeted Revenue and the Percent of Budget Expended on the Statement of Actual & Budgeted Expenditures should both be at 42% if collected and expended evenly throughout the year.

Budgetary Fund Balance is the cumulative residual balance after subtracting expenses from revenues, based on a cash basis. Budgetary Fund Balance at May 31, 2017 was \$15 million in the General Fund, \$118,179 in the Neighborhood Services Fund, \$3,241 in Sanitation and \$8,928 in Disposal. Finance agreed to the accuracy of the amounts for the December 2016 Budgetary Fund Balance on February 6, 2017. The Remaining Budgetary Fund Balance amounts in the report were calculated by subtracting the 2017 Appropriated Budgetary Fund Balance and 2017 Year-to-Date Expenditures from the December 31, 2016 Budgetary Fund Balance, then adding the 2017 Year-to-Date Revenues.

Through the end of May:

1. Solicitor's Office has expended or encumbered 53% of its services budget.
2. The Bureau of Financial Management has expended or encumbered 68% of its services budget.
3. Information Technology has expended or encumbered 54% of its services budget, 69% of its supplies budget and 93% of its other budget.
4. Parks and Recreation has expended or encumbered 80% of its services budget, 85% of its supplies budget and 61% of its other budget.
5. Police has expended or encumbered 57% of its services budget and 71% of its supplies budget.
6. Vehicle Management has expended or encumbered 59% of its services budget and 64% supplies budget.
7. Debt Service Fund has expended or encumbered 71% of its other budget.
8. State Liquid Fuel Tax Fund has expended or encumbered 70% of its supplies budget.
9. Neighborhood Services Fund has expended or encumbered 59% of its supplies budget.
10. Harrisburg Senators Fund had expended or encumbered 74% of its other budget.
11. Police Protection Fund has expended or encumbered 77% of its other budget.
12. Parks and Recreation Fund has expended or encumbered 65% of its services budget and 72% of its other budget.

**SUBJECT:** Revenue and Expenditure Reports

Attached are the Controller's Summary of Budget to Actual report, Selected Budgetary Fund Balance report and the Budget to Actual report for the period ending June 30, 2017.

For the period ending June 2017, Percent Collected on the Statements of Actual & Budgeted Revenue and the Percent of Budget Expended on the Statement of Actual & Budgeted Expenditures should both be at 50% if collected and expended evenly throughout the year.

Budgetary Fund Balance is the cumulative residual balance after subtracting expenses from revenues, based on a cash basis. Budgetary Fund Balance at June 30, 2017 was \$17.9 million in the General Fund, \$1.1 million in the Neighborhood Services Fund, \$1.0 million in Sanitation and \$3.9 million in Disposal. Finance agreed to the accuracy of the amounts for the December 2016 Budgetary Fund Balance on February 6, 2017. The Available Budgetary Fund Balance amounts in the report were calculated by subtracting the 2017 Year-to-Date Expenditures and June 2017 Encumbrances from the December 31, 2016 Budgetary Fund Balance, then adding the 2017 Year-to-Date Revenues.

Through the end of June:

1. The Bureau of Financial Management has expended or encumbered 68% of its services budget.
2. Information Technology has expended or encumbered 69% of its supplies budget and 85% of its other budget
3. DBHD Director has expended or encumbered 60% of its personnel budget.
4. Parks and Recreation has expended or encumbered 81% of its services budget, 81% of its supplies budget and 73% of its other budget.
5. Police has expended or encumbered 65% of its services budget and 73% of its supplies budget.
6. Vehicle Management has expended or encumbered 60% of its services budget and 64% supplies budget.
7. Debt Service Fund has expended or encumbered 72% of its other budget.
8. State Liquid Fuel Tax Fund has expended or encumbered 70% of its supplies budget.
9. Host Municipality Fee Fund has encumbered or expended 93% of its other budget.
10. Neighborhood Services Fund has expended or encumbered 63% of its supplies budget.
11. Harrisburg Senators Fund had expended or encumbered 74% of its other budget.
12. Police Protection Fund has expended or encumbered 77% of its other budget.
13. Parks and Recreation Fund has expended or encumbered 72% of its services budget and 72% of its other budget.
14. Events Fund has expended or encumbered 66% of its services budget.

**SUBJECT:** Revenue and Expenditure Reports

Attached are the Controller's Summary of Budget to Actual report, Selected Budgetary Fund Balance report and the Budget to Actual report for the period ending July 31, 2017.

For the period ending July 2017, Percent Collected on the Statements of Actual & Budgeted Revenue and the Percent of Budget Expended on the Statement of Actual & Budgeted Expenditures should both be at 58% if collected and expended evenly throughout the year.

Budgetary Fund Balance is the cumulative residual balance after subtracting expenses from revenues, based on a cash basis. Available Fund Balance at July 31, 2017 was \$17.6 million in the General Fund, \$991,552 in the Neighborhood Services Fund, \$1.0 million in Sanitation and \$3.9 million in Disposal. Finance agreed to the accuracy of the amounts for the December 2016 Budgetary Fund Balance on February 6, 2017. The Available Budgetary Fund Balance amounts in the report were calculated by subtracting the 2017 Year-to-Date Expenditures and July 2017 Encumbrances from the December 31, 2016 Budgetary Fund Balance, then adding the 2017 Year-to-Date Revenues.

Through the end of July:

1. The Bureau of Financial Management has expended or encumbered 68% of its services budget.
2. Information Technology has expended or encumbered 69% of its supplies budget and 85% of its other budget
3. Parks and Recreation has expended or encumbered 81% of its services budget, 82% of its supplies budget and 67% of its other budget.
4. Police has expended or encumbered 67% of its services budget and 82% of its supplies budget.
5. Debt Service Fund has expended or encumbered 73% of its other budget.
6. State Liquid Fuel Tax Fund has expended or encumbered 73% of its supplies budget.
7. Host Municipality Fee Fund has encumbered or expended 93% of its other budget.
8. Neighborhood Services Fund has expended or encumbered 69% of its supplies budget.
9. Harrisburg Senators Fund had expended or encumbered 74% of its other budget.
10. Police Protection Fund has expended or encumbered 77% of its other budget.
11. Parks and Recreation Fund has expended or encumbered 80% of its services budget and 72% of its other budget.
12. Events Fund has expended or encumbered 72% of its services budget.

**SUBJECT:** Revenue and Expenditure Reports

Attached are the Controller's Summary of Budget to Actual report, Selected Budgetary Fund Balance report and the Budget to Actual report for the period ending August 31, 2017.

For the period ending August 2017, Percent Collected on the Statements of Actual & Budgeted Revenue and the Percent of Budget Expended on the Statement of Actual & Budgeted Expenditures should both be at 67% if collected and expended evenly throughout the year.

Budgetary Fund Balance is the cumulative residual balance after subtracting expenses from revenues, based on a cash basis. Available Fund Balance at August 31, 2017 was \$18 million in the General Fund, \$6.2 million in the Neighborhood Services Fund, -\$12,000 in Sanitation and \$72,000 in Disposal. Finance agreed to the accuracy of the amounts for the December 2016 Budgetary Fund Balance on February 6, 2017. The Available Budgetary Fund Balance amounts in the report were calculated by subtracting the 2017 Year-to-Date Expenditures and August 2017 Encumbrances from the December 31, 2016 Budgetary Fund Balance, then adding the 2017 Year-to-Date Revenues.

Through the end of August:

1. Information Technology has expended or encumbered 84% of its other budget
2. Parks and Recreation has expended or encumbered 81% of its services budget and 77% of its supplies budget.
3. Police has expended or encumbered 84% of its supplies budget.
4. Capital Projects Fund has expended or encumbered 96% of its other budget.
5. Host Municipality Fee Fund has expended or encumbered 93% of its other budget.
6. Sanitation Fund has expended or encumbered 100% of its other budget.
7. Disposal Fund has expended or encumbered 98% of its other budget.
8. Harrisburg Senators Fund had expended or encumbered 100% of its services budget.
9. Police Protection Fund has expended or encumbered 77% of its other budget.
10. Parks and Recreation Fund has expended or encumbered 79% of its services budget.
11. Events Fund has expended or encumbered 75% of its services budget.

**SUBJECT:** Revenue and Expenditure Reports

Attached are the Controller's Summary of Budget to Actual report, Selected Budgetary Fund Balance report and the Budget to Actual report for the period ending September 30, 2017.

For the period ending September 2017, Percent Collected on the Statements of Actual & Budgeted Revenue and the Percent of Budget Expended on the Statement of Actual & Budgeted Expenditures should both be at 75% if collected and expended evenly throughout the year.

Budgetary Fund Balance is the cumulative residual balance after subtracting expenses from revenues, based on a cash basis. Available Fund Balance at September 30, 2017 was \$17.5 million in the General Fund, \$5.6 million in the Neighborhood Services Fund, -\$11,971 in Sanitation and \$73,593, in Disposal. Finance agreed to the accuracy of the amounts for the December 2016 Budgetary Fund Balance on February 6, 2017. The Available Budgetary Fund Balance amounts in the report were calculated by subtracting the 2017 Year-to-Date Expenditures and September 2017 Encumbrances from the December 31, 2016 Budgetary Fund Balance, then adding the 2017 Year-to-Date Revenues.

Through the end of September:

1. Parks and Recreation has expended or encumbered 83% of its services budget.
2. Fire Bureau has expended or encumbered 100% of its other budget.
3. Capital Projects Fund has expended or encumbered 93% of its other budget.
4. Host Municipality Fee Fund has expended or encumbered 93% of its other budget.
5. Sanitation Fund has expended or encumbered 100% of its other budget.
6. Disposal Fund has expended or encumbered 98% of its other budget.
7. Harrisburg Senators Fund has expended or encumbered 100% of its services budget.

**SUBJECT:** Revenue and Expenditure Reports

Attached are the Controller's Summary of Budget to Actual report, Selected Budgetary Fund Balance report and the Budget to Actual report for the period ending October 31, 2017.

For the period ending October 2017, Percent Collected on the Statements of Actual & Budgeted Revenue and the Percent of Budget Expended on the Statement of Actual & Budgeted Expenditures should both be at 83% if collected and expended evenly throughout the year.

Budgetary Fund Balance is the cumulative residual balance after subtracting expenses from revenues, based on a cash basis. Available Fund Balance at October 31, 2017 was \$13.2 million in the General Fund, \$5.9 million in the Neighborhood Services Fund, -\$11,955 in Sanitation and \$148,430 in Disposal. Finance agreed to the accuracy of the amounts for the December 2016 Budgetary Fund Balance on February 6, 2017. The Available Budgetary Fund Balance amounts in the report were calculated by subtracting the 2017 Year-to-Date Expenditures and October 2017 Encumbrances from the December 31, 2016 Budgetary Fund Balance, then adding the 2017 Year-to-Date Revenues.

Through the end of October:

1. Parks and Recreation has expended or encumbered 88% of its supplies budget and 96% of its other budget.
2. Fire Bureau has expended or encumbered 100% of its other budget.
3. Capital Projects Fund has expended or encumbered 96% of its other budget.
4. Host Municipality Fee Fund has expended or encumbered 93% of its other budget.
5. Sanitation Fund has expended or encumbered 100% of its other budget.
6. Disposal Fund has expended or encumbered 98% of its other budget.
7. Events Fund had expended or encumbered 89% of its services budget.

**SUBJECT:** Revenue and Expenditure Reports

Attached are the Controller's Summary of Budget to Actual report, Selected Budgetary Fund Balance report and the Budget to Actual report for the period ending November 30, 2017.

For the period ending November 30, 2017, Percent Collected on the Statements of Actual & Budgeted Revenue and the Percent of Budget Expended on the Statement of Actual & Budgeted Expenditures should both be at 92% if collected and expended evenly throughout the year.

Budgetary Fund Balance is the cumulative residual balance after subtracting expenses from revenues, based on a cash basis. Available Fund Balance at November 30, 2017 was \$17.6 million in the General Fund, \$5.9 million in the Neighborhood Services Fund, -\$9,996 in Sanitation and \$150,817 in Disposal. Finance agreed to the accuracy of the amounts for the December 2016 Budgetary Fund Balance on February 6, 2017. The Available Budgetary Fund Balance amounts in the report were calculated by subtracting the 2017 Year-to-Date Expenditures and November 2017 Encumbrances from the December 31, 2016 Budgetary Fund Balance, then adding the 2017 Year-to-Date Revenues.

Through the end of November:

1. Parks and Recreation has expended or encumbered 93% of its supplies budget.
2. Capital Projects Fund has expended or encumbered 96% of its other budget.
3. Host Municipality Fee Fund has expended or encumbered 93% of its other budget.
4. Sanitation Fund has expended or encumbered 100% of its other budget.
5. Disposal Fund has expended or encumbered 98% of its other budget.
6. Events Fund had expended or encumbered 93% of its services budget.

**SUBJECT:** 2017 Year-End Revenue and Expenditure Reports

Attached is the Controller's Budget to Actual revenue and expenditures report for the year ending December 31, 2017. Based on the attached reports, several observations are worth mentioning:

1. General Fund expenditures plus encumbrances exceeded General Fund revenue by \$341,442. At year end, budgetary fund balance was \$17.9 million.
2. Total General Fund revenue was \$66.3 million. This represents a \$101,900 or 0.2% increase from 2016.
3. In 2017, there were seven General Fund revenue reallocations, raising the General Fund revenue budget from \$65.7 million to \$75.8 million by year end.
4. General Fund budgeted expenditures increased from \$65.7 million to \$73.3 million as a result of the reallocations, giving the administration authorization to expend up to that amount.
5. Appropriation of prior year fund balance increased from \$4.3 million to \$11.2 million due to the seven General Fund budget reallocations.
6. Total General Fund expenditures plus encumbrances was \$66.6 million, \$6.6 million less than the year-end amended budgeted amount of \$73.3 million.
7. General Fund major object personnel expenditures and encumbrances in 2017 were \$38.6 million, a 9.3% increase from \$35.3 million in 2016.
8. General Fund major object service expenditures and encumbrances increased by 26% from \$5.1 million in 2016 to \$6.5 million in 2017.
9. General Fund major object supply expenditures and encumbrances increased by 7.0% from \$2 million in 2016 to \$2.2 million in 2017.
10. General Fund major object category "other" expenditures and encumbrances increased by 49.0% from \$12.9 million in 2016 to \$19.2 million in 2017. Major object category other consists of capital improvements, transfers and general expenses.
11. Neighborhood Services 2017 revenue was \$19.9 million, expenditures plus encumbrances was \$15.6 million, resulting in a \$4.3 million surplus.
